RESERVED RV OVERNIGHT PARKING INFORMATION -- PLEASE READ CAREFULLY – SPACE LIMITED – RESERVE EARLY**

RV Overnight Hours: Wednesday, April 7 – 1:30 PM – 10:00PM; Thursday, April 8 & Friday, April 9 – 6:00AM – 7:00 AM & after Best in Show – 10:00pm; Saturday April 10 - 6:00AM – 7:00AM & after Best in Show – 10:00PM; Sunday, April 11 – 6:00AM – 7:00AM; All vehicles must be off the grounds by 8:00PM Sunday, April 11.

OVERNIGHT & DAY OF SHOW PARKING ARE PRIVILEGES OF MERCED COUNTY FAIRGROUNDS AND YOSEMITE & SIERRA-TUOLUMNE KENNEL CLUBS. THESE PARTIES RESERVE THE RIGHT TO WITHDRAW PRIVILEGES, WITHOUT RETURN OF RV OVERNIGHT PARKING FEE OR ENTRY FEES, FROM ANY PERSON(S) WHO CANNOT ABIDE BY, ABUSES THESE PRIVILEGES OR USES ABUSIVE LANGUAGE. VIOLATORS MAY BE SUBJECT TO EVENT COMMITTEE CHARGES. Please follow the instructions of the RV Overnight parking crew.

ALL PARKING IS AT YOUR OWN RISK. Merced County Fairgrounds, Yosemite & Sierra Tuolumne Kennel Clubs assume NO responsibility or liability for damage or loss to vehicles contents &/or dogs. The Fairgrounds or Clubs takes NO responsibility for vehicles towed in violation of parking laws or regulations & subject to actions of regulatory officers or agents. Vehicles illegally parked will be towed at the owner's expense. The fire department has forbidden any vehicles in fire lanes or any unauthorized area. Exhibitors are responsible for damages & clean up of their parking spaces.

PARKING SPACES WILL BE PRE-ASSIGNED. PEOPLE WISHING TO PARK TOGETHER MUST SEND IN THEIR RESERVATIONS TOGETHER; however there is no guarantee that we can accommodate all requests.

FEE: \$140 PER SPACE FOR ALL 4 NIGHTS. \$35.00 PER NIGHT/PER SPACE. Spaces are 20' x 40'. Vehicles over 40' total length or vehicles with a slide out that will not fit in a 20' x 40' space will need to buy 2 spaces. If your entire package will not fit in a 20' x 40' space, you will need to buy additional space. Trailers & tow units may be required to be unhitched. Vehicles over 40' in length will be accommodated only where possible. Tagalong/Tow vehicle is \$5.00 per night, & must fit into assigned space, if not, they will be accommodated where possible. **TWO NIGHT MINIMUM REQUIRED**

VERY LIMITED HANDICAPPED PARKING will be available; IT MAY NOT NECESSARILY BE CLOSE TO THE RINGS. A suitable access will be provided. Please provide proof of your valid handicapped license with your RV Overnight reservation form. NO NON-RESERVED RV HANDICAPPED WILL BE AVAILABLE.

NO ONE is guaranteed that your parking space will have access to electricity. ELECTRIC CANNOT BE RESERVED, ASSIGNED, REQUESTED, SAVED & / OR GUARANTEED. Please be prepared if you do not have electricity. There will be NO “Piggy Backing” into another rig who is plugged into the Fairgrounds electricity. **NO CORDS** across any sidewalks, walkways, roadways, or fire lanes. Any violators will be disconnected immediately, & MAY be subject to an Events Committee Charges. **THERE IS NO GUARANTEE THAT YOU WILL GET ELECTRICITY NO MATTER WHAT TIME YOU ARRIVE OR WHERE YOU ARE PARKED. Payment of your RV Overnight parking fees does not guarantee electricity.** Should you have electricity, the fairgrounds may require a \$7.50 ‘hook up’ fee.

All vehicles must be completely self-contained, to include power/electric capability. NO discharge of gray water or sanitary tanks allowed.

RV Overnight parking could be on asphalt, cement or crushed granite. BRING GROUND COVER

ALL RV's MUST HAVE WORKING FIRE EXTINGUISHERS.

All RV's using a generator must have a proper exhaust pipe venting away from dogs & people – Quiet time: 11:00 PM – 6:00 AM – No generators

No more that 2 vehicles with a total length of 40' per space, this includes tagalong/tow vehicle.

All vehicles will be parked in the same direction in the rows &/or side-by-side &/or head-to-tail. STRICTLY ENFORCED

RV OVERNIGHT PARKING COORDINATOR ASSIGNS ALL SPACES. DO NOT PROCEED TO ANY RV PARKING SPACE without an escort.
